RE: International Paper-Savannah 2024 Annual Report for EPA's Data Requirements Rule for the 2010 1-Hour SO₂ NAAQS

Dear Ms. Gettle:

This report is being submitted to comply with the ongoing data requirements specified in 40 CFR 51.1205(b), for areas where modeling serves as the basis for designating that area as attainment for the 2010 1-Hour SO₂ NAAQS. The Georgia Environmental Protection Division (EPD) has determined that no additional modeling is needed to characterize air quality in the area surrounding International Paper-Savannah (IP Savannah).

On January 9, 2018, the U.S. Environmental Protection Agency (EPA) designated Chatham County, GA as Attainment/Unclassifiable with an effective date of April 9, 2018 (83 FR 1098). This designation was based on 2011-2013 modeling submitted to EPA by Georgia EPD, which demonstrated that SO₂ emissions from IP Savannah do not cause or contribute to any exceedances of the 1-hour SO₂ National Ambient Air Quality Standard (NAAQS). The highest modeled SO₂ design value in the modeling domain was 66 ppb.

According to the Data Requirements Rule for the 2010 1-hour SO₂ primary NAAQS (80 FR 51052):

"For any area where modeling of actual SO_2 emissions serve as the basis for designating such area as attainment for the 2010 SO_2 NAAQS, the air agency shall submit an annual report to the EPA Regional Administrator by July 1 of each year...that documents the annual SO_2 emissions of each applicable source in each such area... The first report for each such area is due by July 1 of the calendar year after the effective date of the area's initial designation."

Table 1 contains the modeled IP Savannah SO₂ emissions (2011-2013) along with IP Savannah SO₂ emissions (2011-2022) from EPA's Emission Inventory System (EIS).

The 3-year average of IP Savannah SO₂ emissions modeled for 2011-2013 was 6,658 TPY. The 3-year average of SO₂ emissions from IP Savannah for 2020-2022 was 4,185 TPY which is 37.1 percent lower than the modeled emissions for 2011-2013. Therefore, EPD has determined that the previous modeling is conservative, no additional modeling is needed to characterize air quality in the area, and the area continues to meet the 2010 SO₂ NAAQS.
