Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Applicable Law: Georgia Erosion and Sedimentation Act O.C.G.A. 12-7-1 et seq.

Description and Location of Proposed Activity:

Applicant proposes to impact a total of 175 linear feet (20,050 ft<sup>2</sup>) of stream buffer along Crooked Creek to breach a Category 1 high hazard dam and create an upland disposal site outside the stream buffer for the excavated dam material. The dam will be breached to comply with the Georgia Safe Dams Act, and upon completion of disturbance, slopes will be re-vegetated. The project has a total project disturbed acreage 1.5-acres and is located on Ridgeway Church Road.
