**I. NOTICE OF AN APPLICATION FOR A NATIONAL POLLUTANT DISCHARGE ELIMINATION SYSTEM (NPDES) PERMIT TO DISCHARGE TREATED WASTEWATER INTO WATERS OF THE STATE OF GEORGIA**

NPDES permits are valid for a maximum of five years. Prior to expiration of an existing permit, a new application must be submitted and evaluated.

An antidegradation analysis is conducted, as applicable, for new or expanded point source discharges that are proposed. The analysis evaluates whether allowing lower water quality is necessary to accommodate important economic or social development in the area in which the waters are located. In all cases, existing instream water uses and the level of water quality necessary to protect the existing use is maintained and protected.

All municipalities must be in compliance with the Georgia Department of Community Affairs (DCA) Service Delivery Strategy in order to receive a permit.

Having reviewed such applications, the Environmental Protection Division (EPD) is considering the issuance of NPDES permits to the following applicants, subject to specific pollutant limitations and special conditions.

**NPDES PERMIT REISSUANCE**

**Chatham County**

Southern States Phosphate & Fertilizer Company, 1600 East President Street, Savannah, Georgia 31404, NPDES Permit No. GA0002437, for its sulfuric acid production and granular fertilizer warehouse facility located at 1600 East President Street, Savannah, Georgia in Chatham County. An average of 0.5 MGD of non-contact cooling water, stormwater, boiler blowdown, boiler condensate, and spills & emergency response water is discharged to the Savannah Harbor in the Savannah River Basin.

**Crawford County**

City of Roberta, PO Box 278, Roberta, GA 31078, NPDES Permit No. GA0020834, for the Roberta Water Pollution Control Plant located at 165 McAfee Road, Roberta, GA 31078. Up to 0.44 MGD of treated wastewater is being discharged to an unnamed tributary of Culpepper Creek in the Flint River Basin.

Greenleaf Investment Partners L026D, LLC, 2700 Northeast Expressway, Suite C100, Atlanta, Georgia 30345, NPDES Permit No. GA0023043, for its Dixie Mobile Home Park Water Pollution Control Plant (WPCP) located at 3675 Tistshaw Drive, in Gainesville, Georgia. Up to 0.0043 MGD of treated wastewater is being discharged to Flat Creek in the Chattahoochee River Basin.

A maximum of 0.014 MGD of boiler blowdown is discharged to an unnamed tributary to Cedar Creek in the Oconee River Basin.
