This notice is issued to inform the public of a receipt of an Application for a variance submitted pursuant to a state environmental law. The public is invited to comment during the 30-day period on the proposed activity. Site Plans are available for review and are located in the following EPD office: Watershed Protection Branch 200 Piedmont Avenue, S.W. Suite 418 West Atlanta, Georgia 30334. Since the EPD has no authority to zone property or determine land use, only those comments addressing environmental issues related to air, water, and land protection will be considered in the application review process. Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Applicable Law: Georgia Erosion and Sedimentation Act O.C.G.A. 12-7-1 et seq.

Applicable Rules: Erosion and Sedimentation Control Chapter 391-3-7

Basis under which variance shall be considered {391-3-7-.05(2)(a-k)}: (a) & (h)

Description and Location of Proposed Activity: The proposed project would impact Perennial Stream (PS) 5, Intermittent Stream (IS) 8, PS 9, and IS 7 for pedestrian upgrades. The project would impact 12,172 square feet/ 411 linear feet of the 25-foot state mandated buffer within the Upper Chattahoochee Watershed (HUC 03130001). Disturbance activities will consist of the construction of sidewalks, the placement of fill for slopes, clearing and grubbing for construction access, gravity walls, the reconstruction of a stormwater outfall, and the placement of silt fence, orange barrier fence (OBF), and other erosion and sediment control measures within the buffer.

Summary of Rules Requirements for Variance Application:

The application for a variance must include an approved Erosion and Sediment Control Plan with control measures based on sound conservation and engineering practices which meet or exceed the standards in the "Manual for Erosion and Sediment Control in Georgia" and which will minimize erosion and deposition of sediments on adjacent lands or into State waters.
