Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Applicable Law: Georgia Erosion and Sedimentation Act O.C.G.A. 12-7-1 et seq.

Basis under which variance shall be considered {391-3-7.05 (2)(a-k)}: a & h

Description and Location of Proposed Activity: The proposed project would impact Intermittent Stream (IS) 1, IS 5, and Open Water (OW) 7 for the bridge replacement and realignment of State Route (SR) 169 over Goose Creek in Wayne County. The project would impact the 25-foot state mandated buffer under criteria 2(a & h) within the Altamaha River Watershed (HUC 03070106). Disturbance activities would include clearing and grubbing, the placement of fill, and the placement of erosion and sedimentation control best management practices (BMPs) such as OBF.
