Description and Location of Proposed Activity: <u>The proposed project would impact Perennial Stream (PS) 4</u>, <u>Intermittent Stream (IS) 5</u>, PS 15 (Hart Creek), and IS 17 for the construction of I-20 Frontage Rd from Cadley Rd to Ridge Rd. The project would impact 13,536 square feet/ 345 linear feet of the 25-foot state mandated buffer within the Little River watershed. Disturbance activities will consist of grading activities to achieve proper roadside slope and drainage, and clearing to allow for the installation of erosion and sedimentation control best management practices, riprap, and orange barrier fence.
