In accordance with the provisions of the Georgia Comprehensive Solid Waste Management Act, and the Rules promulgated pursuant thereto, this permit is issued for the following operation:

Environmental Remedies, LLC Solid Waste Processing Facility, located in Bibb County at 100 Waste Research Drive in Macon, Georgia. (Latitude 32°48'30" N, Longitude 83°38'05" W).

This permit is conditioned upon the permittee complying with the attached conditions of operation, which are hereby made a part of this permit.

All statements and supporting data submitted to the Environmental Protection Division of the Department of Natural Resources have been evaluated, considered and relied upon in the issuance of this permit.

This permit is now in effect; however, under Georgia law it is subject to appeal for 30 days following issuance, and is subject to modification or revocation on evidence of noncompliance with any provision of the Act or of the Rules promulgated pursuant thereto; or with any representation made in the above mentioned application or the statements and supporting data entered therein or attached thereto; or with any condition of this permit.

- 1. Signs shall be posted at the entrance to the facility stating the days and hours of operation and the types of materials reclaimed.
- 2. Equipment for fire control shall be available at all locations specified in the approved Design and Operations Plan. This equipment shall be maintained in proper operating condition.
- 3. The Design and Operations Plan submitted by the permittee and approved by the Division on January 14, 2013 for this facility is hereby made a part of this permit, and this facility shall be operated in accordance with the approved plan.
- 4. Operation and management of the facility shall be under the direct supervision and control of a responsible individual properly trained in the operation of such facilities at all times during operation.
- 5. Accumulations of putrescible materials and rubbish shall be controlled in a manner so as to minimize odors and prevent infestation by insects or rodents. Insect and rodent control measures shall be applied as needed. Sanitary facilities shall be provided for employees and shall be kept clean and in good repair.
- 6. Any spills or free liquids emanating from waste handled at the facility shall be contained within the permitted structure and promptly remediated. In no event shall washwater or free liquids contaminated by waste be discharged to storm drains or otherwise released to the environment.
- 7. No solid waste may be burned or otherwise disposed of at the facility.
- 8. Unreclaimable materials shall be handled at all times in such a manner as to prevent air, water, and land pollution as well as public health hazards and nuisances.
- 9. Solid waste shall not be stored outside of the building which houses the permitted processing facility. Unreclaimable material shall be transported to a permitted disposal facility immediately upon filling of the storage container. Full containers of incoming or outgoing solid waste shall not be stored on-site.
- 10. Records shall be kept of all materials received, an all materials exiting the facility, sufficient to document compliance. These records shall be kept for a period of at least three years from the date of the record and shall be in a form suitable for submission or inspection by the Division.
- 11. The facility shall be operated in such a manner as to meet air quality standards of the Division.
- 12. The transfer and/or processing of regulated quantities of hazardous wastes is prohibited.
- 13. The permittee shall maintain compliance with all applicable financial responsibility requirements, as provided by Section 391-3-4-.13 of the *Rules for Solid Waste Management*.

14. Person(s) responsible for this processing facility shall notify the Environmental Protection Division 30 days prior to closure of the operation. Following closure, an inspection shall be made by representatives of the Environmental Protection Division and any corrective action found necessary shall be affected as directed by the Environmental Protection Division.
