In accordance with the provisions of the Georgia Comprehensive Solid Waste Management Act, and the Rules promulgated pursuant thereto, this permit is issued for the following facility:

United States Sugar Savannah Refinery, LLC - Private Industrial Landfill, located at W. S. U. S. 17 N. Grange Rd., Port Wentworth, Georgia 31054 (Latitude 32.1435, Longitude - 81.1519).

This Permit is conditioned upon the Permittee complying with the attached Conditions of Operation, which are hereby made a part of this Permit.

All statements in the application and supporting evidence, information, and data submitted to the Environmental Protection Division of the Department of Natural Resources have been evaluated, considered, and relied upon in the issuance of this Permit.

This Permit is now in effect; however, under Georgia law it is subject to appeal for 30 days following issuance and is subject to modification or revocation on evidence of noncompliance: (i) with any provision of the Act or of the Rules promulgated pursuant thereto; or (ii) with any representation made in the above-mentioned application or the statements and supporting data entered therein or attached thereto; or (iii) with any condition of this Permit.

Conditions for Private Industrial Landfill Permit:

1. No hazardous or putrescible waste shall be deposited at the landfill.
2. Materials placed in the landfill shall be spread in layers and compacted to the least practical volume.
3. The disposal site shall be graded and drained to minimize runoff onto the landfill surface, to prevent erosion and to drain water from the surface of the landfill.
4. The landfill shall be operated in such manner as to prevent air, land, or water pollution, public health hazards or nuisances.
5. Access to the landfill shall be limited to authorized entrances which shall be closed when the site is not in operation.
6. Dry filter waste from the sugar refining process, containing approximately 44% calcium carbonate, 50% moisture, and 6% cane fiber impurities shall be the only waste disposed at this site.
