CCR Management Plan Modification Approval

Dear Mr. Purvis:

The Georgia Environmental Protection Division (EPD) received your Request for Minor Modification to Solid Waste Handling Permit (Minor Modification) to revise the Coal Combustion Residuals (CCR) Management Plan on June 13, 2019. The modification sought to revise the acceptable municipal solid waste to CCR ratio in response to a Notice of Violation (NOV) issued May 22, 2019. The request is hereby approved. The deficiencies and violations cited in the aforementioned NOV are satisfied and the facility is considered compliant regarding CCR management.

The approved CCR Management Plan is now part of the facility's Design and Operational Plan and is made part of your Solid Waste Handling Permit. Operating in compliance with the Permit with respect to CCR management requires strict adherence to the procedures of the approved Plan and requires that CCR received at the facility does not differ from that described in the Plan and is not received in amounts that exceed that given in the Plan. This approval does not allow the use of CCR waste in the onsite solidification facility.

Under the plan approved today, this facility may receive CCR until May 21, 2020. An updated CCR Management Plan must be received no later than April 1, 2020 and incorporated into your D&O Plan in no less than one year or you must cease receipt of CCR on May 21, 2020.

EPD is returning approved Design and Operational Plan sheets with this approval letter. One copy of plans will be retained here, and one sent to the Coastal District office, for EPD's files. If you have any questions regarding this letter, please contact Keith Stevens at (404) 362-2539.
