Description and Location of Proposed Activity: <u>The proposed project would impact Open Water (OW) 5, OW</u> 24, OW 28, Buffered State Water (BSW) L, and Intermittent Stream (IS) 30 for the widening and reconstruction of State Route (SR) 32 in Coffee County. A portion of the project is located within the city limits of Douglas. The project would impact the 25-foot state mandated buffer under criteria 2(a & h) within the Satilla River watershed. Disturbance activities would include clearing for construction access, the placement of fill, draining and backfilling of an open water, and the placement of erosion and sedimentation control best management practices (BMPs) such as OBF.
