Description and Location of Proposed Activity: <u>The proposed project would impact Open Water (OW) 17,</u> <u>Buffered State Water (BSW) 21A, Intermittent Stream (IS) 32B, IS 35, OW 37, OW 41, Perennial Stream (PS)</u> 47, OW 52, OW 58, OW 60, IS63, IS 64, OW 70, OW 71, OW 75, PS 75A, OW 76, OW 79, IS 80, PS 82, IS 86A, IS 86B, and IS90 for the widening of US 1 and to construct a bypass around the city of Lyons. The project would impact the 25-foot state mandated buffer under criteria 2(a & h) within the Ohoopee (HUC 03070107) & Altamaha (HUC 03070106) watersheds. Disturbance activities would include grading for the construction of roadside slopes, clearing for construction access, and placement of erosion and sedimentation control best management practices (BMPs).
