Rule 391-3-1-.01, "Definitions," is being amended.

Purpose: This rule is being revised to update the definitions of "Volatile organic

compound," also known as VOC.

Main Features: The definition of "Volatile organic compound" in subparagraph (Illl) is

being updated to add trans-1,1,1,4,4,4-hexafluorobut-2-ene (HFO-1336mzz(E)) to the list of organic compounds having negligible

photochemical reactivity.

Rule 391-3-1-.02(8), "New Source Performance Standards," is being amended.

Purpose: This rule is being revised to adopt the Federal Performance Standards into

the Georgia Rules by reference to ensure consistency between the State and

Federal programs.

Main Features: Subparagraphs (8)(b)1. for General Provisions; (8)(b)16. for Secondary

Lead Smelters for Which Construction, Reconstruction, or Modification Commenced After June 11, 1973, and On or Before December 1, 2022; (8)(b)32. for Steel Plants: Electric Arc Furnaces Constructed Ater October 21, 1974, and On or Before August 17, 1983; (8)(b)33. for Steel Plants: Electric Arc Furnaces and Argon-Oxygen Decarburization Vessels Constructed After August 17, 1983 and On or Before May 16, 2022; (8)(b)40. for Lead-Acid Battery Manufacturing Plants for Which Construction, Reconstruction, or Modification Commenced After January 14, 1980, and On or Before February 23, 2022; (8)(b)42. for Automobile and Light-Duty Truck Surface Coating Operations for which Construction, Modification or Reconstruction Commenced After October 5, 1979, and On or Before May 18, 2022; (8)(b)68. for Industrial Surface Coating: Surface Coating of Plastic Parts for Business Machines; (8)(b)75. for Commercial and Industrial Solid Waste Incineration Units; (8)(b)77. for Stationary Compression Ignition Internal Combustion Engines; (8)(b)79. for Stationary Spark Ignition Internal Combustion Engines; (8)(b)86. for New Residential Wood Heaters; and (8)(b)88. for New Residential Hydronic Heaters and Forced-Air Furnaces are being revised to reflect the latest titles and amendment dates of the incorporated Federal rules.

Rule 391-3-1-.02(9), "Emission Standards for Hazardous Air Pollutants," is being amended.

Paper Industry; (9)(b)52. for Primary Aluminum Reduction Plants; (9)(b)71. for Hazardous Waste Combustors; (9)(b)90. for Ferroalloys Production: Ferromanganese and Silicomanganese; (9)(b)102. for Paper and Other Web Coatings; (9)(b)109. for Surface Coating of Wood Building Products; (9)(b)118. for Stationary Reciprocating Internal Combustion Engines; (9)(b)126. for Miscellaneous Coating Manufacturing; (9)(b)134. for Engine Test Cells/Stands; (9)(b)139. for Coal- and Oil-Fired Electric Utility Steam Generating Units; (9)(b)160. for Lead Acid Battery Manufacturing Area Sources; (9)(b)161. for Wood Preserving Area Sources; and (9)(b)171. for Area Sources: Asphalt Processing and Asphalt Roofing Manufacturing are being revised to reflect the latest titles and

STATEMENT OF RATIONALE Rules for Air Quality Control

Rule 391-3-1-.01 – Definitions.

The basis of this rule is to provide definitions for terms used in the Georgia Rules for Air Quality Control, Chapter 391-3-1. The purpose of this revision is to revise the definition of "Volatile organic compound" in order to be consistent with EPA's definition of "Volatile Organic Compound" as identified in the Code of Federal Regulations.

Rule 391-3-1-.02(8) – New Source Performance Standards.

The basis of this rule is to adopt the Federal New Source Performance Standards (NSPS) by reference. The purpose of this revision is to include the latest amendment dates and all associated changes into the Georgia rules.

Rule 391-3-1-.02(9) – Emission Standards for Hazardous Air Pollutants.

The basis of this rule is to adopt the National Emission Standards for Hazardous Air Pollutants (NESHAP) by reference. The purpose of this revision is to include the latest amendment dates and all associated changes into the Georgia rules.

Rule 391-3-1-.02(12) – Cross State Air Pollution Rule NOx Annual Trading Program.

The basis of this rule is to adopt the Cross-State Air Pollution Rule (CSAPR) NOx Annual Trading Program by reference. The purpose of this revision is to add the latest amendment date of the incorporated Federal rule and to update the new unit set-aside.

Rule 391-3-1-.02(13) – Cross State Air Pollution Rule SO₂ Annual Trading Program.

The basis of this rule is to adopt the Cross-State Air Pollution Rule (CSAPR) SO₂ Annual Group 2 Trading Program by reference. The purpose of this revision is to add the latest amendment date of the incorporated Federal rule and to update the new unit set-aside.

Rule 391-3-1-.02(14) – Cross State Air Pollution Rule NOx Ozone Season Trading Program.

The basis of this rule is to adopt the Cross-State Air Pollution Rule (CSAPR) NOx Ozone Season Group 1 Trading Program by reference. The purpose of this revision is to add the latest amendment date of the incorporated Federal rule and to update the new unit set-aside.

The proposed rule revisions are required to comply with federal requirements or are administrative in nature. They are in no way any more restrictive than the federal requirements. They do not incur any additional costs to the regulated industry, local government, or public other than those required to meet the federal rule.
