Synthetic Minor and Major Source SIP Permits issued after March 30, 2022, will be posted on the Division's draft permit website for Public Notice (PN) for a 30-day period at <https://epd.georgia.gov/draft-title-v-permitsamendments-other-draft-permits>. When the PN has concluded, any comments will be taken into consideration prior to issuing a permit. Permit Types 7-15 in the table above of this SOP already include the PN in the timelines listed.

¹ Not all permits will be accepted into the Expedited Permitting Program. EPD will let applicant know if accepted into the program within 5 business days of receiving request.

³ Any project that has extensive modeling may take longer and the applicant may need to submit a modeling protocol at least 30 days prior to submitting the application. Modeling protocol submittal and approval is not included in the permit timelines.
