## **Proof of Experience**

**Note:** If your experience was obtained under water well contractor(s) or pump contractor(s) <u>not</u> licensed by the State of Georgia, you <u>must provide a copy</u> of the contractors' Water Well Contractor License/Certificate or Pump Contractors' License/Certificate.

Water Well Contractor Applicants (select one of the following):
□ Provide proof of two (2) years of experience working in the water well construction business under licensed water well contractor(s) by submitting certified affidavit(s) from one or more licensed water well contractor(s). An example of an acceptable affidavit is included on page six (6) of this application.
☐ If you are unable to provide affidavit(s) from water well contractor(s) you previously worked under, provide other proof of two (2) years of experience working in the water well construction business under licensed water well contractor(s) for the Council to consider.
☐ You may apply by reciprocity if you have a <b>valid</b> water well contractor license in the state of Alabama or Mississippi. Provide a copy of that license.
☐ If applying to restore an expired Water Well Contractor License, provide a copy of your expired license.
Pump Contractor Applicants (select one of the following):
☐ Provide proof of two (2) years of experience working in the pump installation business under certified pump contractor(s) by submitting certified affidavit(s) from one or more certified pump contractor(s). An example of an acceptable affidavit is included on page six (6) of this application
☐ If you are unable to provide affidavit(s) from pump contractor(s) you previously worked under, provide other proof of two (2) years of experience working in the pump installation business under certified pump contractor(s) for the Council to consider.
☐ Grandfather Option: This is available if you can provide documentation that you have been in the business of installing, removing, or servicing pumps and pumping equipment prior to December 31, 2003.
☐ If applying to restore an expired Pump Contractor Certificate, provide a copy of your expired certificate.

#### **Photo Identification**

Attach a copy of a valid, government-issued photo identification. Examples of acceptable identification include a copy of the applicant's current valid Driver License or passport.

### **Application Fee**

Include an application fee of \$100.00 made payable to the "Department of Natural Resources". This application fee can be in the form of a check or a money order.

**Note:** The Department of Natural Resources <u>requires a three week hold time</u> to ensure fees are properly deposited. You may submit the license or certificate fee at the time of application to avoid waiting three weeks after the Council's decision. All other Council mandated submittals are required to be submitted prior to a license or certificate being issued.

#### **What to Expect After Submitting Your Application:**

- Complete applications will be forwarded to the Water Well Standards Advisory Council for consideration at the next scheduled meeting.
- Notice will be given by first class mail of the Council's decision to approve or deny an application.
  - o If your application is approved by the Council, the two items listed below are required to be submitted prior to license or certificate issuance. The Council may require additional items to be submitted for license or certificate issuance. If additional items are required, EPD will provide notice of these items within the Council's decision letter.
    - 1. A performance bond or letter of credit in the amount of \$30,000 for water well contractors and \$20,000 for pump contractors. Templates of these documents can be found at https://epd.georgia.gov/watershed-protection-branch/water-well-standards.
    - 2. A license or certificate fee in the amount of \$400 payable to the Department of Natural Resources if **more than one (1) year** of the license or certificate cycle remains, **or** a license or certificate fee in the amount of \$200 payable to the Department of Natural Resources if **one (1) year or less** of the license or certificate cycle remains.
- All Water Well Contractor Licenses expire on June 30<sup>th</sup> of odd numbered years.
- All Pump Contractor Certificates expire on June 30<sup>th</sup> of even numbered years.
