NOTICE OF PUBLIC HEARING AND PROPOSED AMENDMENTS TO GEORGIA'S STATE IMPLEMENTATION PLAN

TO ALL INTERESTED PERSONS AND PARTIES:

Notice is hereby given that, pursuant to the authority set forth below, the Environmental Protection Division (hereinafter, "EPD") of the Georgia Department of Natural Resources proposes amendments to Georgia's State Implementation Plan (SIP). The proposed revision is described below:

The proposed State Implementation Plan revision includes Georgia's request under the Clean Air Act that the Atlanta 8-hour ozone nonattainment area be redesignated to attainment with respect to the 2015 National Ambient Air Quality Standard (NAAQS) for ozone as well as Georgia's plan to maintain attainment of the 2015 8-hour ozone standard in the Atlanta area.
