This notice is issued to inform the public of a receipt of an application for a variance submitted pursuant to a state environmental Law. Since the EPD has no authority to zone property or determine land use, only those comments addressing environmental issues related to air, water, and land protection will be considered in the application review process. Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Applicable Law: Georgia Erosion and Sedimentation Act O.C.G.A. 12-7-1 et seq.

Basis under which variance shall be considered {391-3-7-.05 (2)(a-k)}: (a)

Description and Location of Proposed Activity:

The proposed project will consist of removing an existing asphalt trail and constructing a new 10-ft wide concrete trail for approximately 5,000 linear feet from Lee Street in the City of Winder to Fort Yargo State Park. Mitigation for the permanent buffer impacts will consist of removing all non-native invasive plant species along the proposed trail and planting native riparian trees and shrubs within the buffer (approximately 3,540 square feet total – including *Red Maple*, *Loblolly Pine*, *Smooth Alder*, *Silky and Flowering Dogwoods*, *American Elder*, *Possumhaw*, *Northern Spicebush* and *Buttonbush*. The proposed project will result in approximately 260 linear feet total (2,600 square feet total) of buffer disturbances along an unnamed perennial stream, a tributary to Fort Yargo Lake in the *Upper Oconee Watershed*.

The application for a variance must include an approved Erosion and Sediment Control Plan with control measures based on sound conservation and engineering practices which meet or exceed the standards in the "Manual for Erosion and Sediment Control in Georgia" and which will minimize erosion and deposition of sediments on adjacent lands or into State waters.
