This notice is issued to inform the public of a receipt of an application for a variance submitted pursuant to a state environmental law. The public is invited to comment during the 30-day period on the proposed activity. Site Plans are available for review and are located in the following EPD office: Watershed Protection Branch 200 Piedmont Avenue, S.W. Suite 418 West Atlanta, Georgia 30334. Since the EPD has no authority to zone property or determine land use, only those comments addressing environmental issues related to air, water, and land protection will be considered in the application review process. Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Applicable Law: Georgia Erosion and Sedimentation Act O.C.G.A. 12-7-1 et seq.

Applicable Rules: Erosion and Sedimentation Control Chapter 391-3-7

Basis under which variance shall be considered {391-3-7.05 (2)(a-k)}: (a) & (h)

Description and Location of Proposed Activity:

The proposed project will impact the buffer of Intermittent Stream (IS) 02, IS 03, and Perennial Stream (PS) 04 (unnamed tributaries of Duncan Creek). The project will widen SR 211 from the I-85 interchange to the intersection with Pinot Noir Drive and improve 1,200 feet of I-85 Frontage Road in Barrow County/City of Braselton. The project will impact the state mandated 25-ft buffer within the Upper Oconee Watershed (HUC 03070101). The disturbance will cover 3,758 square feet and include clearing for construction access, fill impacts, construction of a culvert, redirection of a stream, and the installation of Best Management Practices (BMPs).

Summary of Rules Requirements for Variance Application:

The application for a variance must include an approved Erosion and Sediment Control Plan with control measures based on sound conservation and engineering practices which meet or exceed the standards in the "Manual for Erosion and Sediment Control in Georgia" and which will minimize erosion and deposition of sediments on adjacent lands or into State waters.
