Activity

This notice is issued to inform the public of a receipt of an Application for a variance submitted pursuant to a state environmental law. The public is invited to comment during the 30-day period on the proposed activity. Site Plans are available for review and are located in the following EPD office: Watershed Protection Branch 200 Piedmont Avenue, S.W. Suite 418 West Atlanta, Georgia 30334. Since the EPD has no authority to zone property or determine land use, only those comments addressing environmental issues related to air, water, and land protection will be considered in the application review process. Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Applicable Law: Georgia Erosion and Sedimentation Act O.C.G.A. 12-7-1 et seq.

Applicable Rules: Erosion and Sedimentation Control Chapter 391-3-7

Basis under which variance shall be considered {391-3-7.05 (2)(a-k)}: a & h

Description and Location of Proposed Activity: The project proposes to widen and reconstruct sections of SR 140 and will impact buffers along Intermittent stream (IS) 3, IS 5, IS 6, and Perennial stream (PS) 9 (Woodward Creek), PS 12, IS 13, IS 14, IS 20 (tributaries to Woodward Creek), and PS 26 (tributary to Oothkalooga Creek) within the Oostanaula River Basin. Activities include culvert/pipe extension, new pipes, clearing for temporary construction access, installation of orange barrier fencing, and cut and/or fill for the widening of the roadway embankment. The project will result in 69,892 square feet of buffer disturbance.

Summary of Rules Requirements for Variance Application:

The application for a variance must include an approved Erosion and Sediment Control Plan with control measures based on sound conservation and engineering practices which meet or exceed the standards in the "Manual for Erosion and Sediment Control in Georgia" and which will minimize erosion and deposition of sediments on adjacent lands or into State waters.
