Description and Location of Proposed Activity:

The proposed project intends to stabilize the eroding streambank and provide access along a private residence on Hastings Road in the city of Cartersville, Bartow County. Land disturbing activities include riprap placement, bio-engineering practices, and revegetation. Encroachments total 1,692 square feet along 125 linear feet within the buffer of the Etowah River. The project is within the Etowah Watershed (03150104). Revegetation practices will utilize multi-trophic, native riparian vegetation.
