Description and Location of Proposed Activity:

The proposed project involves buffer encroachments necessary to construct an electric vehicle, original equipment manufacturing facility. The site will accommodate vehicle production, product testing, battery cell production, distribution, training, employee services and associated infrastructure. The project will be located on a 2,541.25-acre site located in the southeast quadrant of the Interstate 16 and Highway 280 intersection in Bryan County. The project will require 1,660 acres of disturbance including permanent impacts (pipe/fill) to 3,363 linear feet (166,834.8 square feet) of buffer along three unnamed tributaries to Black Creek in the Lower Ogeechee Watershed (03060202).
