Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Description and Location of Proposed Activity:

This proposed project involves buffer encroachments necessary to construct a data center and associated infrastructure east of the Towaliga River off GA HWY 16 E in Butts County. Additionally, an on-site stormwater management system (including stormwater ponds and grassed channels) will be included. The project will require 229.35 acres of land disturbance including permanent impacts (pipe/fill) to 366 total linear feet (21,300 total square feet) of buffer along two unnamed tributaries to the Towaliga River in the Upper Ocmulgee Watershed (03070103).

Summary of Rules Requirements for Variance Application:

The application for a variance must include an Erosion and Sediment Control Plan with control measures based on sound conservation and engineering practices which meet or exceed the standards in the "Manual for Erosion and Sediment Control in Georgia" and which will minimize erosion and deposition of sediments on adjacent lands or into State waters.
