Activity

This notice is issued to inform the public of a receipt of an application for a variance submitted pursuant to a state environmental Law. The public is invited to comment during the 30-day period on the proposed activity. Since the EPD has no authority to zone property or determine land use, only those comments addressing environmental issues related to air, water, and land protection will be considered in the application review process. Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Applicable Law: Georgia Erosion and Sedimentation Act O.C.G.A. § 12-7-1 et seq.

Applicable Rules: Erosion and Sedimentation Control Chapter 391-3-7

Basis under which variance shall be considered {391-3-7-.05 (2)(a-k)}: (a)

Description and Location of Proposed Activity:

The proposed project aims to improve and maintain an existing dam located south of Horsley Mill Road in the City of Carrollton, Carroll County, Georgia. Land disturbing activities will include improvements to the pond dam, primary spillway, and emergency spillway, and are designed to manage stormwater more effectively. Buffer encroachments necessary for this project total 500 linear feet (14,168 square feet) of buffer associated with an unnamed tributary of Buffalo Creek. The project is located within the Upper Tallapoosa Watershed (03150108).

Summary of Rules Requirements for Variance Application:

The application for a variance must include an Erosion and Sediment Control Plan with control measures based on sound conservation and engineering practices which meet or exceed the standards in the "Manual for Erosion and Sediment Control in Georgia" and which will minimize erosion and deposition of sediments on adjacent lands or into State waters.
