Description and Location of Proposed Activity: <u>The proposed project will impact Jurisdictional Ditch (JD) 105.</u> <u>The project will widen sections of Interstate 16 and improve the I-16/I-95 interchange. The project will impact the state mandated 25-ft buffer within the Little Ogeechee Coastal (HUC 03060204) watershed. The disturbance will cover 12,861 square feet and include cut and fill slopes to accommodate roadway re-alignment and the installation of Best Management Practices (BMPs).</u>
