Since the EPD has no authority to zone property or determine land use, only those comments addressing environmental issues related to air, water, and land protection will be considered in the application review process. Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Applicable Law: Georgia Erosion and Sedimentation Act O.C.G.A. 12-7-1 et seq.

Applicable Rules: Erosion and Sedimentation Control Chapter 391-3-7

Basis under which variance shall be considered {391-3-7.05 (2)(a-k)}: a & h

Description and Location of Proposed Activity: The proposed project will impact Canal (CL) 2, CL 3, CL 4, CL 5, CL 7, CL 8, CL 12, and CL 13. The project will create a new roadway beginning at the intersection of State Route (SR) 25/Main Street and SR 25 Connector/Burnsed Boulevard and ending at existing Brampton Road in Garden City, Chatham County, Georgia. The project will impact the state mandated 25-ft buffer within the Lower Savannah River Watershed (HUC 03060109). The disturbance will cover 54,482 square feet and include placement of fill, clearing for roadway construction, clearing for utility rights-of-way, installation of curb and gutter, removal of existing railroad tracks, installation of utility poles, construction access, and the installation of Best Management Practices (BMPs).
