This notice is issued to inform the public of a receipt of an application for a variance submitted pursuant to a state environmental Law. The public is invited to comment during the 30-day period on the proposed activity. Site plans are available for review and are located in the following EPD office: Watershed Protection Branch, 200 Piedmont Avenue SW, Suite 418 West, Atlanta, GA 30334. Since the EPD has no authority to zone property or determine land use, only those comments addressing environmental issues related to air, water, and land protection will be considered in the application review process. Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Applicable Law: Georgia Erosion and Sedimentation Act O.C.G.A. 12-7-1 et seq.

Applicable Rules: Erosion and Sedimentation Control Chapter 391-3-7

Basis under which variance shall be considered {391-3-7-.05 (2)(a-k)}: (a)

Description and Location of Proposed Activity:

Keeter Lake (an existing recreational pond) is located along Lori Lane and Mills Ridge Drive in Cherokee County. The existing High Hazard Category I Dam is not in compliance with the *Georgia Safe Dams Act*. Therefore, this project will consist of removing the existing principal and auxiliary spillways and breaching the earthen dam (i.e., vnotch with a riprap lined channel with 2H:1V slopes to the stream gradient). Mitigation will consist of planting native riparian vegetation along the v-notch channel (including *Arrowwood* and *Buttonbush* shrubs and *River Birch* and *Sugar Maple* trees). This project will result in approximately 131 linear feet total (9,590 square feet total) of buffer disturbances along Keeter Lake and an unnamed perennial stream, tributaries to Blankets Creek in the *Etowah Watershed*.

Summary of Rules Requirements for Variance Application:

The application for a variance must include an approved Erosion and Sediment Control Plan with control measures based on sound conservation and engineering practices which meet or exceed the standards in the "Manual for Erosion and Sediment Control in Georgia" and which will minimize erosion and deposition of sediments on adjacent lands or into State waters.
