Description and Location of Proposed Activity:

This project involves the construction of an entrance road from Georgia Highway 20 to support a 50.81 acre corporate park. During construction of the entrance road, a portion of the intermittent stream will be piped and covered with fill to support the proposed use, to include no other proposed buffer encroachments. The proposed project will result in 522 linear feet (28.085 square feet) of buffer disturbance along an unnamed intermittent stream to the Etowah River in the Etowah Watershed (03150104).
