Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Applicable Law: Georgia Erosion and Sedimentation Act O.C.G.A. § 12-7-1 et seq.

Applicable Rules: Erosion and Sedimentation Control Chapter 391-3-7

Basis under which variance shall be considered {391-3-7-.05 (2)(a-k)}: (a)

Description and Location of Proposed Activity:

The proposed project will upgrade and enhance an existing dam outlet control device. Disturbance of the buffer is necessary in order to perform essential preventative maintenance to meet current safety standards. A Revegetation Plan and erosion control measures are implemented to address major impacts. The proposed project will result in 580 total linear feet (7,454 total square feet) of buffer disturbance lasting approximately 1 month. The project is located on an unnamed impoundment of the Etowah Watershed (03150104).

The application for a variance must include an Erosion and Sediment Control Plan with control measures based on sound conservation and engineering practices which meet or exceed the standards in the "Manual for Erosion and Sediment Control in Georgia" and which will minimize erosion and deposition of sediments on adjacent lands or into State waters.
