Description and Location of Proposed Activity:

The proposed project features construction of a kayak/canoe launch and related access in Cherokee County. Land disturbing activities include minor clearing, placement of gravel path, elevated walkway construction, and stabilization practices. Encroachments total 1,512 square feet along 257 linear feet within the buffers of the Etowah River and Long Swamp Creek. The project is in the Etowah Watershed (03150104).
