Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Applicable Law: Georgia Erosion and Sedimentation Act O.C.G.A. § 12-7-1 et seq.

Applicable Rules: Erosion and Sedimentation Control Chapter 391-3-7

Basis under which variance shall be considered {391-3-7-.05 (2)(a-k)}: (h)

Description and Location of Proposed Activity:

The proposed project involves buffer encroachments necessary for the construction of a grocery store supermarket, ancillary buildings, parking areas and driveways off of Towne Lake Parkway. The project will require 10.07-acres of land disturbance including permanent impacts (pipe/fill) to 449 total linear feet (25,700.4 total square feet) of State Waters buffer lasting approximately 1 year. The project is located on an unnamed tributary to Noonday Creek of the Etowah Watershed (03150104). The project will incorporate water quality BMPs to satisfy both water quality protection and hydrologic protection requirements.

The application for a variance must include an Erosion and Sediment Control Plan with control measures based on sound conservation and engineering practices which meet or exceed the standards in the "Manual for Erosion and Sediment Control in Georgia" and which will minimize erosion and deposition of sediments on adjacent lands or into State waters.
