Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Applicable Law: Georgia Erosion and Sedimentation Act O.C.G.A. § 12-7-1 et seq.

Applicable Rules: Erosion and Sedimentation Control Chapter 391-3-7

Basis under which variance shall be considered {391-3-7-.05 (2)(a-k)}: (b)

Description and Location of Proposed Activity:

The proposed project will make improvements to a streambank and stream bed exhibiting severe incision and erosion. Disturbance of the buffer is necessary in order to prevent future erosional activity and significant loss of property. A Revegetation Plan and erosion control measures are implemented to address major impacts. The proposed project will result in 283 total linear feet (3,557 total square feet) of buffer disturbance lasting approximately 6 weeks. The project is located on an unnamed tributary to McNutt Creek of the Upper Oconee Watershed (03070101).
