This notice is issued to inform the public of a receipt of an Application for a variance submitted pursuant to a state environmental Law. Since the EPD has no authority to zone property or determine land use, only those comments addressing environmental issues related to air, water, and land protection will be considered in the application review process. Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Applicable Law: Georgia Erosion and Sedimentation Act O.C.G.A. 12-7-1 et seq.

Applicable Rules: Erosion and Sedimentation Control Chapter 391-3-7

Basis under which variance shall be considered {391-3-7.05 (2)(A-K)}: A

Description and Location of Proposed Activity:

Applicant proposes to impact 360 linear feet (26,950ft²) of stream buffer along an impoundment to Willeo Creek. The dam improvements include modifying the crest and flattening the slopes. Also included are impacts to repair the existing spillway, which has begun to headcut with a risk of breaching the dam. Installation of a new principal spillway siphon system and a vegetated spillway with an armored pilot channel will bring the dam into compliance. A small retaining wall, 2' high, will impact the buffer for 25 ft² in order to divert any stormwater from the adjacent homeowner. Project is located on Wenden Lane off Freeman Rd. in Cobb County.

Summary of Rules Requirements for Variance Application:

The application for a variance must include an Erosion and Sediment Control Plan with control measures based on sound conservation and engineering practices which meet or exceed the standards in the "Manual for Erosion and Sediment Control in Georgia" and which will minimize erosion and deposition of sediments on adjacent lands or into State waters.
