This notice is issued to inform the public of a receipt of an Application for a variance submitted pursuant to a state environmental law. The public is invited to comment during the 30-day period on the proposed activity. Since the EPD has no authority to zone property or determine land use, only those comments addressing environmental issues related to air, water, and land protection will be considered in the application review process. Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Applicable Law: Georgia Erosion and Sedimentation Act O.C.G.A. § 12-7-1 et seq.

Applicable Rules: Erosion and Sedimentation Control Chapter 391-3-7

Basis under which variance shall be considered {391-3-7.05 (2)(a-k)}: (a)

Description and Location of Proposed Activity:

The proposed project will impact the buffer of Perennial Stream (PS) 1, Intermittent Stream (IS) 2, and PS 4 (unnamed tributaries to Sweetwater Creek). The project will construct a sidewalk along a segment of Old Alabama Road in the City of Mableton/Cobb County, Georgia. The project will impact the state mandated 25-ft buffer within the Middle Chattahoochee-Lake Harding watershed (HUC 03130002). The disturbance will cover 3,534 square feet and include construction of drainage features, driveway realignment, placement of riprap, easement for construction access, clearing and grubbing, fill for construction of slopes, roadway, and sidewalk, and the installation of Best Management Practices (BMPs).

The application for a variance must include an Erosion and Sediment Control Plan with control measures based on sound conservation and engineering practices which meet or exceed the standards in the "Manual for Erosion and Sediment Control in Georgia" and which will minimize erosion and deposition of sediments on adjacent lands or into State waters.
