Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Description and Location of Proposed Activity:

The proposed project involves buffer encroachments necessary to facilitate construction of a 117,036 square foot warehouse building with associated parking lots and infrastructure in Cobb County. The project requires 14.84 acres of disturbance including permanent impacts to 471.3 linear feet (22,222 square feet) of buffer associated with a tributary of the Chattahoochee River. The site is located southwest of White Road and bisected by Factory Shoals Road: it is within the Middle Chattahoochee Watershed (HUC 03130002).
