This notice is issued to inform the public of a receipt of an application for a variance submitted pursuant to a state environmental Law. Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Applicable Law: Georgia Erosion and Sedimentation Act O.C.G.A. § 12-7-1 et seq.

Applicable Rules: Erosion and Sedimentation Control Chapter 391-3-7

Basis under which variance shall be considered {391-3-7-.05 (2)(a-k)}: (a)

Description and Location of Proposed Activity:

The streambank improvement project and proposed activities aim to stabilize the eroding streambank along the Chattahoochee River. Land disturbing activities will include re-grading for bio-engineering stabilization and installation of a drainage pipe and headwall. Buffer disturbances total 6,225 square feet along 245 linear feet. The site is located behind The Eddy at Riverview Landing apartment complex in the city of Smyrna, Cobb County and is within the Chattahoochee Watershed (03130002). The completion of the project will enhance the riparian buffer to a functioning system, improve water quality, and increase stormwater resiliency.

The application for a variance must include an Erosion and Sediment Control Plan with control measures based on sound conservation and engineering practices which meet or exceed the standards in the "Manual for Erosion and Sediment Control in Georgia" and which will minimize erosion and deposition of sediments on adjacent lands or into State waters.
