Description and Location of Proposed Activity:

This proposed project involves buffer encroachments necessary to stabilize seven separate streambanks along Indian Hills Country Club golf course. The streambank stabilization and restoration plans consist of grading the eroding streambanks to a more stable slope and revegetation with rip-rap, cribwalls, live stakes and grasses. The project will require 0.15 acres of disturbance including permanent impacts to 425 total linear feet (5,614 total square feet) of buffer along Sope Creek and Bishop Creek in the Upper Chattahoochee Watershed (03130001).

The application for a variance must include an Erosion and Sediment Control Plan with control measures based on sound conservation and engineering practices which meet or exceed the standards in the "Manual for Erosion and Sediment Control in Georgia" and which will minimize erosion and deposition of sediments on adjacent lands or into State waters.
