This notice is issued to inform the public of a receipt of an application for a variance submitted pursuant to a state environmental Law. The public is invited to comment during the 30-day period on the proposed activity. Since the EPD has no authority to zone property or determine land use, only those comments addressing environmental issues related to air, water, and land protection will be considered in the application review process. Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Applicable Law: Georgia Erosion and Sedimentation Act O.C.G.A. § 12-7-1 et seq.

Applicable Rules: Erosion and Sedimentation Control Chapter 391-3-7

Basis under which variance shall be considered {391-3-7-.05 (2)(a-k)}: (a)

Description and Location of Proposed Activity:

The proposed project involves buffer encroachments necessary to facilitate stormwater improvements and address water quality concerns for a private property on Polo Lane, unincorporated Cobb County. Land disturbing activities for this project include replacement of existing culvert and headwall, stormwater management installation, necessary BMPs, and stabilization practices. Encroachments total 3,283 square feet along 84 linear feet of buffer associated with Gilmore Creek. The site is within the Upper and Middle Chattahoochee Watersheds (03010001 and 03130002).

The application for a variance must include an Erosion and Sediment Control Plan with control measures based on sound conservation and engineering practices which meet or exceed the standards in the "Manual for Erosion and Sediment Control in Georgia" and which will minimize erosion and deposition of sediments on adjacent lands or into State waters.
