Activity

This notice is issued to inform the public of a receipt of an Application for a variance submitted pursuant to a state environmental law. The public is invited to comment during the 30-day period on the proposed activity. Site Plans are available for review and are located in the following EPD office: Watershed Protection Branch 200 Piedmont Avenue, S.W. Suite 418 West Atlanta, Georgia 30334. Since the EPD has no authority to zone property or determine land use, only those comments addressing environmental issues related to air, water, and land protection will be considered in the application review process. Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Applicable Law: Georgia Erosion and Sedimentation Act O.C.G.A. 12-7-1 et seq.

Applicable Rules: Erosion and Sedimentation Control Chapter 391-3-7

Basis under which variance shall be considered {391-3-7.05 (2)(a-k)}: (a), (h), (k)1

Description and Location of Proposed Activity: The proposed project would impact Perennial Stream (PS) 8/Okapilco Creek, Open Water (OW) 10 (drains into Okapilco Creek), Intermittent Stream (IS) 14 (tributary to Okapilco Creek), IS 25 (tributary to Ochlockonee River), OW 31 (drains to Ochlockonee River), PS 42 (tributary to Ochlockonee River), Buffered State Water (BSW) K (drains to Ochlockonee River), BSW L (drains to Ochlockonee River), BSW M (drains to Ochlockonee River), and BSW P (drains to Ochlockonee River), for Criteria 2(a); under Criteria 2(h) for IS 14, IS 25, and PS 42; and under Criteria 2(k)1 for BSW P. The proposed project includes the road widening and reconstruction of SR 133 from South of SR 35/US 319 to North of Mike Horne Road in Colquitt County. The proposed project would impact the 25-foot state mandated buffer under criteria 2(a, h & k1) within the Withlacoochee (HUC 03110203) and Upper Ochlockonee (HUC 3120002) Watersheds. Disturbance activities would include clearing and grubbing, the placement of fill, and the placement of erosion and sedimentation control best management practices (BMPs) such as OBF.

The application for a variance must include an approved Erosion and Sediment Control Plan with control measures based on sound conservation and engineering practices which meet or exceed the standards in the "Manual for Erosion and Sediment Control in Georgia" and which will minimize erosion and deposition of sediments on adjacent lands or into State waters.
