Description and Location of Proposed Activity: The proposed project will impact the buffer of Intermittent Stream (IS) 2a (unnamed tributary to Reed Creek). The project will construct a stormwater management pond for the Shoppes of Petersburg in Columbia County. The project will impact the state mandated 25-ft buffer within the Middle Savannah watershed (HUC 03060106). The disturbance will cover 10,866 square feet and include clearing, grading of slopes, dam construction, and the installation of Best Management Practices (BMPs).
