Description and Location of Proposed Activity:

This proposed project involves buffer encroachments necessary to construct a warehouse and associated infrastructure at the intersection of Interstate Way and GA HWY 34 East in Coweta County. The project will require 11.78 acres of disturbance including permanent impacts (pipe/fill) to 487.77 total linear feet (31,624.56 total square feet) of buffer along an unnamed tributary to White Oak Creek in the Upper Flint Watershed (03130005).
