Description and Location of Proposed Activity:

This proposed project will consist of constructing a new single-family detached residential development and associated infrastructure off Green Top Road in the city of Newnan, Coweta County. The project will require approximately 108 acres of disturbance including buffer impacts for unregulated dam structure rehabilitation and maintenance, and gravity sewer installation. Pond embankment will be stabilized with native grasses and all gravity sewer area will be returned to original grade and stabilized. Construction activities will result in approximately 794.12 total linear feet (23,090.15 total square feet) of buffer impacts along an unnamed tributary to Wahoo Creek in the Middle Chattahoochee Watershed (03130002).
