This notice is issued to inform the public of a receipt of an application for a variance submitted pursuant to a state environmental Law. Since the EPD has no authority to zone property or determine land use, only those comments addressing environmental issues related to air, water, and land protection will be considered in the application review process. Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Applicable Law: Georgia Erosion and Sedimentation Act O.C.G.A. § 12-7-1 et seq.

Applicable Rules: Erosion and Sedimentation Control Chapter 391-3-7

Basis under which variance shall be considered {391-3-7.05 (2)(a-k)}: (a)

Description and Location of Proposed Activity:

The proposed project will impact the buffer of Perennial Stream (PS) 4 and PS 5 (tributaries to Pope Creek). The project will replace the existing 427-foot (6 spans) County Road (CR) 145/Slygo Road bridge built in 1966 over Interstate (I)-24 and Pope Creek. The project will impact the state mandated 25-ft buffer within the Middle Tennessee-Chickamauga Watershed (06020001). The disturbance will cover 4,019 square feet (508 linear feet) and include bridge construction on the existing alignment, but will be raised approximately 3.17 feet to provide adequate clearance over I-24 westbounds and installations of BMPs.

The application for a variance must include an Erosion and Sediment Control Plan with control measures based on sound conservation and engineering practices which meet or exceed the standards in the "Manual for Erosion and Sediment Control in Georgia" and which will minimize erosion and deposition of sediments on adjacent lands or into State waters.
