Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Description and Location of Proposed Activity:

The proposed project will consist of constructing a gravel access road (6-inch compacted gravel aggregate base (GAB) material) for the installation and maintenance of a floating, in-stream trash / litter trap in North Fork Nancy Creek in Murphey Candler Park in Brookhaven. All disturbed areas will be returned to original grade and stabilized with mulching and permanent vegetation and restored to current conditions to the extent practicable. This project will result in approximately 75 linear feet total (1,655 square feet total) of buffer impacts along North Fork Nancy Creek, a tributary to Murphey Candler Lake in the *Upper Chattahoochee Watershed*.
