Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Applicable Law: Georgia Erosion and Sedimentation Act O.C.G.A. 12-7-1 et seq.

Description and Location of Proposed Activity:

The proposed project will consist of constructing a new master planned residential development and associated infrastructure on approximately 8.9 acres at the intersection of Eastland Road and Lake Drive in DeKalb County. This project will include an on-site stormwater management system (including a bioretention basin (without an underdrain) and three wet extended detention (ED) ponds). The proposed project will result in permanent buffer impacts to approximately 238 linear feet total (17,524 square feet total) of an unnamed intermittent stream, a tributary to Intrenchment Creek in the *Upper Ocmulgee Watershed*.
