Description and Location of Proposed Activity:

The proposed project will consist of constructing a new service center and associated infrastructure for the Roto-Rooter Services Company on approximately 3.66 acres (formerly Affordable Family Health Services and OMB Beauty Supply Store) along Pleasantdale Road and Dawson Boulevard (I-85 Access Road) in DeKalb County. This project will also include an on-site stormwater management system (including underground detention). The proposed project will result in temporary buffer impacts (including removal of existing pavement) to approximately 173 linear feet total (1,064 square feet total) along Kitchen Creek in the *Upper Chattahoochee Watershed*.
