Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Basis under which variance shall be considered {391-3-7-.05 (2)(a-k)}: (d)

Description and Location of Proposed Activity:

The proposed sanitary sewer system improvement project will consist of abandoning-in-place and/or removing existing sanitary sewer lines and installing approximately 1,078 linear feet of 26" Ø DIP, 1,098 linear feet of 18" Ø DIP, 137 linear feet of 30" Ø DIP and 1,733 linear feet of 36" Ø DIP sanitary sewer lines and associated manholes along Brookfield Lane, Misty Valley Road, Tulip Drive and Glenwood Road in DeKalb County. All disturbed areas will be returned to original grade and stabilized with mulching and permanent vegetation and all open-cut trenches will be backfilled and restored to current conditions to the extent practicable. Construction activities will result in approximately 3,138 linear feet total (60,570 square feet total) of buffer disturbances along Cobbs Creek in the *Upper Ocmulgee Watershed*.
