This notice is issued to inform the public of a receipt of an application for a variance submitted pursuant to a state environmental Law. Since the EPD has no authority to zone property or determine land use, only those comments addressing environmental issues related to air, water, and land protection will be considered in the application review process. Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Applicable Law: Georgia Erosion and Sedimentation Act O.C.G.A. 12-7-1 et seq.

Applicable Rules: Erosion and Sedimentation Control Chapter 391-3-7

Basis under which variance shall be considered {391-3-7-.05 (2)(a-k)}: (a) and (d)

Description and Location of Proposed Activity:

Continued streambank erosion along Henderson Mill Creek has impacted an existing sanitary sewer line and water main crossing located along Rangewood Terrace in DeKalb County. The proposed streambank stabilization project will consist of grading the eroding streambank to a more slope and integrated bio-engineering practices (including joint plantings with *Black Willow* and *Silky Dogwood* live stake cuttings and permanent native riparian seed mix). In addition, the damaged 16" Ø water main located along Rangewood Terrace will be replaced. This project will result in approximately 803 linear feet total (13,539 square feet total) of buffer disturbances (including a temporary access road) along an unnamed tributary to Henderson Mill Creek and Henderson Mill Creek in the *Upper Chattahoochee Watershed*.

The application for a variance must include an approved Erosion and Sediment Control Plan with control measures based on sound conservation and engineering practices which meet or exceed the standards in the "Manual for Erosion and Sediment Control in Georgia" and which will minimize erosion and deposition of sediments on adjacent lands or into State waters.
