Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Applicable Law: Georgia Erosion and Sedimentation Act O.C.G.A. § 12-7-1 et seq.

Basis under which variance shall be considered {391-3-7-.05 (2)(a-k)}: (d)

Description and Location of Proposed Activity:

The proposed sewer project intends to redirect flows from Lucky Shoals Creek and Camp Creek sewersheds within Gwinnett and DeKalb County. The project features construction of three new lift stations, decommissioning of four current lift stations, and installation of new gravity sewer line. Land disturbing activities include clearing, grubbing, open-cut trenching, line installation, and BMPs. These impacts total 43,739 square feet along 4,684 linear feet within the buffers of an unnamed tributary to Camp Creek and an unnamed tributary to Lucky Shoals Creek. The project is within the Upper Ocmulgee Watershed (03070103) and disturbed areas will be restored to the extent practicable upon completion of the project.
