The proposed project intends to provide passive recreational components to Needham Park in DeKalb County. Land disturbing activities include boardwalk and concrete placement for paths, bridge construction, BMP implementation, and stabilization practices. Encroachments necessary fore this project total 6,106 square feet along 520 linear feet within the buffer of an unnamed tributary of South Fork Peachtree Creek. The project is in the Upper Chattahoochee Watershed (03130001). The site will be revegetated with multi-trophic, native riparian species.
