Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Description and Location of Proposed Activity:

The proposed project will consist of constructing a new cross-dock warehouse facility and associated infrastructure on approximately 153.5 acres along Britt Road in Douglas County. This project will include an on-site stormwater management system (including two (2) wet extended detention (ED) ponds with *Hydro International Downstream Defender*® hydrodynamic vortex separators). The proposed project will result in permanent buffer impacts (16,303 square feet total) along approximately 295 linear feet of an unnamed intermittent stream, a tributary to Chattahoochee River in the *Middle Chattahoochee – Lake Harding Watershed*.
