Type of Permit Application: Variance to encroach within the 25-foot State waters buffer.

Basis under which variance shall be considered {391-3-7.05 (2)(A-K)}: A & H

Description and Location of Proposed Activity:

Douglas County Department of Transportation proposes to impact 201 linear feet (4,874 ft²) of a tributary to Anneewakee Creek. Impacts are for intersection improvements for southbound and eastbound turn lanes and sidewalks. There will be 47 linear feet (1,425 ft²) of permanent impacts to the tributary for relocation and pipe and fill. The additional 154 linear feet (3,449 ft²) of stream buffer impact is for fill slopes for the intersection improvements. The project is on Stewart Mill Rd. at the intersection with Reynolds Road.
